SECTION 1.6, Bid Proposal, Page 5 of 18, Bid Item 110, PG 64-28 Asphalt Cement. **DELETE** quantity "71" and **INSERT** quantity "61".

SECTION 1.6, Bid Proposal, Page 5 of 18, Bid Item 111, Bituminous Tack Coat. **DELETE** quantity "4" and **INSERT** quantity "3".

SECTION 1.6, Bid Proposal, **DELETE** Page 4 through 6 of 18, **INSERT** new Schedule 1 Bid Item sheets 4 through 6, attached at the end of the Addendum.

**Technical Specification**

P-101, Preparation/Removal of Existing Pavement, Page 5 of 6, Method of Measurement, **ADD** to the end of the section.

**101-4.3 Pavement removal, Asphalt.** The unit of measurement for pavement removal shall be the number of cubic yards (cubic meters) removed by the Contractor. Any pavement removed outside the limits of removal because the pavement was damaged by negligence on the part of the Contractor shall not be included in the measurement for payment.

P-101, Preparation/Removal of Existing Pavement, Page 5 of 6, Basis of Payment, Item P 101-5.1, Asphalt Millings Removal, **DELETE** "Millings" and **INSERT** "Pavement".





